
A WEEK AGO I FOUND OUT THAT THE DOCTOR WHO REFUSED TO GIVE ME ANY MORE PROSTAGLANDINS WAS A CONSCIENTIOUS OBJECTOR (...) NOW, PROBABLY BECAUSE OF THIS PERSON, I WILL HAVE TO UNDERGO AN OPERATION THAT COULD HAVE BEEN EASILY AVOIDED IF HE HAD CHOSEN TO DO HIS JOB PROPERLY. (LOMBARDY 2020)

HELLO, I CONFIRM THAT HAVING AN ABORTION IN BASILICATA IS A TORTURE (...) AT THE BEGINNING I WENT TO A DOCTOR WHO TRIED TO MAKE ME WASTE TIME AND THEN SHE TOLD ME THAT SHE WAS AGAINST ABORTION (...) MY 'ORDEAL' STARTED 15 DAYS AGO AFTER A POSITIVE TEST, EVEN THOUGH I HAD TAKEN THE MORNING-AFTER PILL. (...). AFTER MORE THAN 15 DAYS MY AGONY IS FINALLY 'OVER' YES, BECAUSE HAVING AN ABORTION IN BASILICATA IS AGONY.


My gynaecologist had advised me to go to hospital very early, 4 am, because there is a lot of waiting. At that time, there were already people arriving before me. At 8 o'clock they open the hospital but they only accept four visits a day because out of 25 gynaecologists only four perform abortions. (Campania)

The staff is unfriendly and rude, responding evasively to patients' questions and often giving inaccurate or wrong information. (...) The staff behaves very badly with migrant women in particular (...) Faced with my complaints, the doctor dared to shout at me in the waiting room, humiliating me in front of everyone. (Lazio)



They are planning to perform the operation in week 11, at the limit of the legal deadline. They stretch the bureaucratic deadlines to exhaustion, apparently consciously, providing partial or deliberately wrong information.

When I had an abortion in this hospital, I was treated badly, with hatred, contempt, and they made me feel like a monster.

They allow the anti-abortionist groups to stand outside the clinic on the days when they operate so that they can leaflet and insult the women that just had an abortion.

Despite the fact that my prescription stated 'gynaecological examination for termination of pregnancy' (...) the gynaecologist not only did not examine me, but laughed in my face and dismissed me by prescribing folic acid. (Lombardy)
